INTERVIEW COMPLAINANT:

Hannah Elise Painter w/f 5/10/90

██████████ stated she is being harassed by her ex-boyfriend ██████████. She stated she has been at the rehabilitation center since March 25th, 2012. She stated recently she received two calls from a person by the name of ██████████. She stated the first message just left a cell phone number for a call back. The second message from ██████████ was just adding to the first stating "I love you and I am proud of you." I asked ██████████ why she thinks it is Michael who is calling, she stated the call back number on the message was Michael's cell phone and Michael's middle name is ██████████. I asked ██████████ if she called Michael back, she stated she has not contacted Michael at all and has no interest in talking to him. She stated she doesn't know what is going on with Michael, she thinks Michael maybe trying to contact her or could end up possibly stalking her. I asked her what she meant by this. ██████████ stated Michael thought she was going to rehab in the Detroit area, so unless he just starting calling rehab centers, he must have a good idea of where she is. ██████████ stated she thinks Michael took some mail out of her parents mailbox back in Ohio and found out where she is. I asked her to explain this. ██████████ stated she sent her mother a card for Easter with the address of the rehab center on it. She stated her mom never received the card and it was never sent back to her, so she thinks Michael got ahold of the mail and found out where she is. I asked ██████████ if there was a history of violence between her and Michael at any point in their relationship, she stated once when they lived in Florida. She stated he was never prosecuted for the violence because she dropped the charges. I asked ██████████ if she thinks Michael would come to Manistee to try and make contact with her, she stated she thinks Michael could come to Manistee. ██████████ stated she would like a protection order in case Michael were to come to Manistee. I gave ██████████ information on how to go about filling out the paperwork for a protection order. I asked ██████████ if she would like a written report on file, she stated she would.
