INFORMATION:

On the above date and time, I was requested to Best Drug Rehab for an assault that had just occurred. Both parties were separated at this time. Upon arrival, I was met by Jason Burdge, Executive Director of Best Drug Rehab. Burdge advised that a [REDACTED] and [REDACTED] had gotten into an incident in a room. I first spoke with [REDACTED] advised that he was cleaning his room, in room 207, when a [REDACTED] came in and started telling him how he should behave. [REDACTED] stated that his roommate walked in and [REDACTED] told him to close the door. [REDACTED] then started talking to him again and [REDACTED] advised that he tried to leave the room but [REDACTED] wouldn't let him and shoved [REDACTED]. [REDACTED] then went to lay down in his bed, when [REDACTED] then took off his shirt, putting it over [REDACTED] mouth and then [REDACTED] stated he yelled for Security. At this time, [REDACTED] advised that [REDACTED] jumped on top of him and started hitting him in the head. [REDACTED]'s room mate then pulled

Wilson off of him and [REDACTED] ran out of the room to Burdge's office. (SEE [REDACTED]'S WRITTEN STATEMENT)

I then proceeded to speak with [REDACTED] (Suspect). I asked [REDACTED] what happened with [REDACTED] and he advised that he was trying to talk with [REDACTED] and it didn't work. He stated that one thing led to another and he took his shirt off and put it over [REDACTED]'s mouth and hit him 3 times (twice in the head and once in the stomach). He stated then [REDACTED] ran out of the room. (SEE [REDACTED]'S WRITTEN STATEMENT)

I advised both parties that a report will be sent to the Manistee County Prosecutor's Office for their review.

INFORMATION: Additional Request From Prosecutor's Office

I was requested by the Prosecutor's Office to get a statement from a potential witness to the assault and battery. I located a [REDACTED] who advised that he was in the hallway, outside of the room, listening to what was going on and being said. He stated that he heard [REDACTED] tell [REDACTED] to start behaving. A short time later he heard a thump inside the room area so he went inside. When he went in, he seen the two pushing and arguing and heard [REDACTED] using racial slurs toward [REDACTED]. [REDACTED] then said how would you like your shirt in your mouth so the security would not hear you screaming for help while you get beat up. [REDACTED] then started hitting [REDACTED] and then [REDACTED] finally flipped [REDACTED] off and yelled for Security. [REDACTED] stated that [REDACTED] did hit [REDACTED] several times throughout the event.
